SECTION I: BACKGROUND

Gujarat Mineral Development Corporation Ltd (GMDC) is a leading Public Sector Mining and Minerals Company of Gujarat with operational experience of over 60 years. GMDC product portfolio spans across mining, value added products and power. Its power portfolio includes clean energy sources such as solar and wind besides thermal power.

GMDC mining activities are spread across Gujarat in Kutch, Devbhoomi Dwarka, Panchmahal, Vadodara, Bhavnagar, Bharuch, Surat and Chhotaudepur districts of the State. It is currently mining minerals like Lignite with five operational lignite mines, Bauxite (11 operating mines), Fluorspar, Manganese, Ball Clay, Silica Sand, Bentonitic Clay and Limestone. GMDC also adds value to minerals through works such as Pyrite removal from Lignite, Beneficiation of Bauxite, Beneficiation of Low-Grade Manganese and Beneficiation of Fluorspar. The Company has set up a 250 MW lignite based Thermal Power Station at Nani Chher in Kutch as a forward integration, Wind power plant of 200.9 MW at Maliya, Jodiya, Godsar, Bhanvad, Bada, Verbala, Rojmal and Solar Power plant of 5 MW at Panandhro Project.

The Shyamji Krishna Varma Memorial, also known as Kranti Teerth, stands as a living tribute to this towering patriot in Mandvi, Kachchh, spreading over 52 acres of solemn and inspiring landscape. The memorial houses a replica of India House, along with statues of Shri Shyamji Krishna Varma and his devoted wife, Bhanumati, whose ashes—brought from Geneva in 2003—rest here as eternal symbols of their unwavering bond with the nation.

The Memorial goals to Honoring Shyamji Krishna Varma's Contributions and sacrifices for independence who championed revolutionary ideals from London, including establishing India House. Commemorating Other Freedom Fighters, Educating Future Generations, Inspiring Patriotism and National Unity. The replica of India House, a center of revolutionary activity in London, serves to recreate the historical environment and educate visitors about the importance of such spaces in the freedom struggle.

The memorial complex has an amphitheatre, walkways, viewing galleries, exhibits and an assortment of programmes for children and adults. The place is a tribute to Shri Shyamji Krishna Varma and other freedom fighters who dedicated their lives to liberate the Indian subcontinent from colonial rule. On an average, the Memorial sees nearly 300 visitors every day and on special occasions, there can be a manifold surge in numbers, exceeding 5,000 guests.

The memorial is located in Village Maska, Taluka Mandvi, Dist. Kutch, Gujarat, India.

- Nearest City: Mandvi
- Nearest Railway Station: Bhuj (around 64 km away). Bhuj is connected by trains from major cities like Ahmedabad, Mumbai, and Delhi.
- Nearest Airport: Bhuj Airport (BHJ). One can find flights to Bhuj from various cities.

SECTION II: SCOPE OF WORK/PROPOSAL DETAILS

The detailed Scope of Work, for **Green Space Enhancement and Landscaping Service for SKV Memorial, at Mandvi, Kutch, Gujarat** is specified in this section.

1. Scope of Work

The Service Provider shall be required to execute the works as under in two phases:

An area of around 29 Acres in the SKV Memorial aims to be developed, as an aesthetically refined and environmentally sustainable landscape, comprising a variety of designated functional zones.

1.1 SKV Memorial Landscaping Enhancement

- Freedom Pillars: Small stone/metal pillars engraved with quotes from Shyamji Krishna Varma and other freedom fighters.
- Murals & Wall Art: Artistic walls showing scenes of the independence movement.
- Pathway Elements with Tri-color themed patterns.
- Benches & Seating Corners with freedom motifs (e.g., Ashoka Chakra).

1.2 Yatra Garden: A Journey of Freedom Struggle

The Yatra Garden spanning around in an area of around 5.23 Acre is envisioned as a living tribute to the brave souls who fought for India's independence. Designed as a journey through landscaped spaces, it reflects the key phases of the freedom struggle-each node symbolizing a powerful idea, movement, or moment that shaped the nation's destiny. Set in nature, the garden aims to inspire reflection, resilience, and patriotism while educating visitors about the spirit of India's fight for freedom. Special focus on SKV role & journey in freedom struggle,

The five nodes will represent the **emotional, political, and social milestones** of the freedom movement, expressed through meaningful landscaping, sculpture, pathways, and native planting.

1. First node (Awakening) - symbolizes the beginning of the awakening of India's collective consciousness and the push for independence.
 - **Visuals** - A peaceful, reflective space with serene landscapes describing early nationalist movements and intellectual contributions by leaders, who started the foundation for a radical awakening in the youth.
2. Second node (Revolt) - The revolt phase is marked by the first major uprising against British colonial rule.
 - **Visuals** - A dynamic, energy-filled part with sculptures of rebellious figures or artifacts symbolizing revolts. Stark contrasts, aggressive plant shapes, and symbolic pathways could represent the fervor of the people during this phase.
3. Third node (Non-Cooperation) - This section represents the mass awakening, when the Indian masses, under freedom fighter leaders, boycotted British institutions and promoted swadeshi (self-reliance).
 - **Visuals** - Peaceful, orderly gardens symbolizing unity and non-violence. A vast open area with benches for people to sit and reflect could symbolize the vast movement and its non-cooperation tactics.



4. Fourth node (Sacrifice) - The emotional core of the garden, this section would reflect the immense personal sacrifices made by the leaders and common people alike.
 - **Visuals** - A solemn, sacred space with sculptural representations of martyrs, soldiers, and leaders who gave their lives for the cause. Shyamji Krishna Varma's own sacrifices, including his exile and lifelong dedication to India's cause. The stories of countless martyrs who stood for the freedom struggle could be told through interactive displays.
5. Fifth node (Independence) - The culmination of the long struggle, representing the dawn of a free and independent India.
 - **Visuals:** The final moments of India's independence struggle and how Shyamji Krishna Varma's efforts paved the way for future generations.

1.3 Dhyan Kutir

The Dhyan Kutir is a serene meditation space aimed to design to offer solitude and a deep connection with nature. Nestled within dense native plantations and surrounded by aromatic plants, soft grass, filtered sunlight, birds sound, it will create a peaceful atmosphere for mindfulness, relaxation, and rejuvenation.

1.4 Park/Greenspace

Park will be developed to honor the memory of freedom fighter Shri SK Verma. Spread over about 2 acres, the park will have seating spaces, walking paths, native trees, flowering plants, and shrubs. It will offer a peaceful and green environment for visitors to relax and reflect.

The use of local plant species and proper irrigation systems will help maintain the park year-round. The aim is to create a clean, natural, and welcoming space that also supports biodiversity and community well-being.

1.5 Dense Buffer Plantation

A dense buffer plantation over an area of around 2.19 acre adjacent to the SKV Museum strategically planted with dense vegetation, typically consisting of trees, shrubs, and other plants.

A well-planned dense buffer plantation at the Kranti Teerth Memorial will not only protect the site but also enhance its ecological and educational value.

It aims to shield the memorial from dust, wind, and noise, enhancing visitor experience, support local wildlife and plant species, contributing to ecological balance and creating a visually appealing landscape that complements the memorial's heritage.

1.6 Water Body Rejuvenation

- The water body (Existing Pond in an area of approx. 2 acres) is to be replenished which may Provide a habitat for aquatic and semi-aquatic species. This aims to enhance the visual appeal of the memorial by introducing a reflective water surface amid the greenery & creates a serene and calming environment for visitors, complementing the memorial's contemplative atmosphere.
- Natural sit outs around the structure.
- Enhancement and beautification around the canal.



1.7 Avenue & Peripheral Plantation

Aiming to create a green boundary around the memorial to enhance aesthetics, provide ecological protection, and improve biodiversity over an area of around 2 Acres, including avenue plantation along roads, pathways spanning across an area of around 1 acre to serve both practical and aesthetic purposes enhancing the memorial's visual appeal, provide shade, along Sub Roads. Tree plantation should be of around 4m width on both sides of sub-Road with mix of Shrub, Small Canopy Trees, Medium Canopy Trees and Large Canopy Trees.

1.8 Parking area Plantation

The Existing Parking area (1.3 Acre) located near the entrance and accessible via the main road provides organized and convenient parking to visitors. The plantation across the parking area aims to provide memorial a natural and aesthetic environment.

1.9 Staff Quarter Green space

The Staff Quarter area will be developed as a clean, green, and comfortable living environment with well-planned landscaping. Native trees, flowering shrubs, will enhance the daily living experience of staff members while promoting ecological balance with a healthy, pleasant, and nature-connected.

The project will be executed in **two major phases**, covering landscape development and hardscape & maintenance works across the SKV Memorial premises. The complete work shall be carried out within stipulated timeline of around 300 days with infrastructure support, various soil & water conservation measures, soil enrichment work with maintenance of landscapes for at least 3 years.

1.2.1 Phase 1: Preliminary Works – Plantation & Landscaping Development

This phase includes **site preparation, irrigation system installation, soil improvement, and plantation works** across multiple zones. The landscape areas to be developed are:

1. Avenue Plantation – 1 Acre

Development of tree-lined avenues using a mix of shrubs, small, medium, and large canopy species along designated roads and pathways.

2. Peripheral Plantation – 2 Acres

Creation of a green boundary around the memorial using native trees and shrubs to enhance aesthetics and ecological protection.

3. Park/Greenspace and Dense Buffer Plantation– 4.19 Acres

Park with greenspace and Dense, layered plantation to replicate a rainforest environment with high biodiversity, thick canopy, and natural undergrowth.

4. Yatra Garden Plantation – 5.32 Acres

Green development of the thematic Yatra Garden representing phases of the freedom struggle with native landscaping and structured planting.

5. Water Body Landscape – 2 Acres

Rejuvenation of the existing pond with aquatic and semi-aquatic plants, natural sit-outs, and surrounding beautification.

6. Dhyan Kutir Green– 0.04 Acre

A serene meditation pocket developed with aromatic plants, soft grass, and shaded greenery to create a peaceful ambience.

1.2.2 Stage 2: Hardscape (Civil) Works

This stage includes construction, installation, finishing of civil elements, and associated maintenance. The components include:

1. Yatra Garden Hardscape – 1500 sqm

Development of thematic plazas, node structures, and landscape-built elements.

2. Yatra Garden Pathways – 2190 sqm

Construction of walkways, connecting routes, and circulation paths with durable and aesthetic finishes.

3. Outdoor Furniture & Sit-Outs – 10 Nos.

Provision and installation of durable outdoor seating units integrated into landscaped spaces.


4. Elements - Sculptures / Stone Pillars – 10 Nos.

Installation of symbolic sculptures, thematic stone pillars, and commemorative elements supporting the narrative of the memorial.

5. Arch Trellis Structures – 30 Nos.

Installation of decorative trellis arches designed to support climbers and enhance walkway aesthetics.

2. Support from GMDC-GVT

1.1. EOI Process

2. GENERAL

2.1. Proposal Validity

Such misrepresentation/ improper response/blacklisting/record of poor performance shall lead to the disqualification of the Service providers. If such disqualification / rejection occur after the Proposals have been opened and the Service providers gets disqualified / rejected, then GMDC-GVT reserves the right to:

7. FRAUD AND CORRUPT PRACTICES

6. **“restrictive practice”** means forming a cartel or arriving at any understanding or arrangement among Service providers with the objective of restricting or manipulating a full and fair competition in the EOI Process.

8. CONFLICT OF INTEREST

- a) The Service providers shall not have a conflict of interest that may affect the Selection Process or the Service Provision (the “Conflict of Interest”).
